**Recipients and admission procedures**

May apply for the available positions, 1 student currently enrolled in the courses of:

- Master degree in Scienze e Tecnologie Alimentari, second year;
- Master degree in Food Safety and Risk Management, second year;
- PhD in Food Sciences;

and 1 student currently enrolled in the courses of:

- Master degree in Engineering for the Food Industry;
- PhD in Industrial Engineering

The candidates have to be enrolled at the University of Parma and they have to possess a good knowledge of the English language, comparable at least to the CEFR B2 level.

Applications have to be submitted **by midnight of the 25/05/2025** using the following methods:

**Documents to attach to the application**

- Curriculum Vitae.
- Scientific publications and conference certificates of participation.
- Certifications or self-certifications of training/work experiences/mobility abroad.
- International certifications (Cambridge, TOEFL, Trinity, IELTS) of knowledge of the English language at least B2 level, or self-certification of linguistic proficiency obtained during the university course of studies at least B2 level. The Commission reserves the right to evaluate the admission of candidates who present certificates of knowledge of the language other than those indicated above.
- Copy of a valid identification and of codice fiscale

The data entered will be processed solely for institutional purposes of the University of Parma (Personal Data Protection Code – Legislative Decree 30/6/2003, No. 196 and subsequent amendments and the European Regulation on the protection of personal data, No. 679/2016) and exclusively related to the execution of this call for applications.

### **Assignment**

The Evaluation Commission, appointed by the President of the School of Advanced Studies on Food and Nutrition, will evaluate the candidates according to the criteria established and based on the excellence of the candidate's profile and linguistic skills.

In the event of equal scores, priority will be given to the youngest candidate.

### **Acceptance**

Students identified as eligible for free participation in the Course will receive communication exclusively via e-mail to the address indicated in the application.

The selected candidate will have to reply to the e-mail by confirming their participation within 3 days of the emission of the communication.
